

**BOX ELDER COUNTY
2014 PRIMARY ELECTION**

The Board of County Commissioners of Box Elder County, Utah, met at the County Courthouse, 01 South Main Street, Brigham City, Utah at 6:00 p.m. on Tuesday, July 8, 2014 to conduct a canvass of returns from the 2014 Box Elder County Primary Election pursuant to Utah Code Unannotated 20A-4-304. The following members were present constituting a quorum:

Clerk Marla R. Young conducted the canvass. A cursory review of the ballot tabulations was made. The results of the canvass are attached.

Ms. Young stated there were 4,227 ballots cast. Three by-mail/absentee ballots were received after Tuesday, June 24, which were timely post marked. Thirty by-mail/absentee ballots were post marked after June 24, and were not counted. The Thirty uncounted ballots were sealed in an envelope and filed with the 2014 Primary Election results. The percentage of ballots counted on election night was 17.08 percent, a total of 4,102 ballots.

There were 82 voted provisional ballots counted and 15 not counted (Provisional Ballot Report attached). After counting the valid by-mail, absentee ballots and provisional ballots, the percentage of ballots counted was 17.60 percent, a total of 4,227 ballots. The 15 provisional ballots, which were not counted, were sealed in an envelope and filed with the 2014 Primary Election results.

Ms. Young reviewed the audit procedures with the Board. She said Box Elder County was required to audit four machines which were randomly picked by the Lt. Governor. An audit of the totals tape and the tape inside the canisters was performed on four machines; one used in the Box Elder County Courthouse Early, two used in the USU Education Center Vote Center and one used in the Mantua Town Hall Vote Center. She reported that the totals matched. A copy of the audit report is attached.

MOTION: A motion was made by Commissioner Scott to accept the results of the 2014 Primary Election as submitted by the Clerk-Election Official. The motion was seconded by Commissioner Tingey and unanimously carried.
